**Pearl Business Class** Checked baggage: Bags with a total weight not exceeding 40kg. Items must not exceed the dimensions 45cm x 72cm x 90cm. Even if you choose to exceed your luggage allowance (at an additional cost), each item must not exceed 32kg. Carry-on baggage: 2 bags with a total weight not exceeding 12kg. Each item must not exceed maximum total dimensions of 115 cm (for example, 60 x 35 x 20).

**Coral Economy Class** Checked baggage: Bags with a total weight not exceeding 30kg. Items must not exceed the dimensions 45cm x 72cm x 90cm. Even if you choose to exceed your luggage allowance (at an additional cost), each item must not exceed 32kg. Carry-on baggage: 1 bag with a total weight not exceeding 7kg. Each item must not exceed maximum total dimensions of 115 cm (for example, 60 x 35 x 20).

**Infants (applicable in any class of travel)** Checked baggage: 1 bag with a total weight not exceeding 30 kg (66 lbs), including carry cot/car seat and all other accessories.

Carry-on baggage: 1 bag. Each item must not exceed a maximum total dimension of 115 cm (for example, 60 x 35 x 20). Maximum total weight is 7kg.

**Infants (applicable in any class of travel)** Checked baggage: 1 bag. Each item must not exceed 23kg (50lbs) and a maximum total dimension of 158 cm (for example, 50 x 70 by x 38).

Etihad Airways is committed to acknowledging receipt of your complaint within 30 days and to providing a substantive response within 60 days.

**Notice** If the passenger's journey involves an ultimate destination or a stop in a country other than the country of origin, the Warsaw Convention or the Montreal Convention as stated in the conditions of carriage of passengers and baggage may apply to the entire journey, including any portion entirely within the country of origin or destination. These conventions may limit the liability of the carrier for loss of life or bodily injury; in respect of delay, and for loss or damage to baggage.

Etihad Airways has waived the limits of liability applicable under the Warsaw Convention (or that Convention as amended at The Hague 1955 or protocols nos. 1 and 2 of 1975) with respect to loss of life or bodily injury attributable to an accident. However, under the Warsaw Convention (or that Convention as amended at the Hague 1955 or protocols nos. 1 and 2 of 1975) the liability for the loss, damage or destruction of checked baggage is limited to 17 SDR per kilogram (about USD 20).

Under the Montréal Convention of 1999, no financial limits apply in the case of loss of life or bodily injury. Etihad Airways may make advance payments to meet immediate economic needs of the person entitled to claim compensation, subject to applicable law. The liability of Etihad Airways in respect of damage caused by delay is limited to SDR 4150 (about USD 6200) and the liability in respect of destruction, loss, damage, or delay of baggage is limited to SDR 1000 about (USD1,500.)

For flights originating from any state member of the European Union Etihad Airways is committed to respect the specific European Regulations relating to liability in case of denied boarding, cancellation of a flight or substantial delay.

For security reasons, all knives, sharp objects or cutting implements of any kind and any length, whether of metal or other material, knitting needles, and sporting goods, must be packed in your checked baggage. They cannot be carried in cabin baggage or on person. Passengers carrying hypodermic needles will need to declare them at the screening point. Where possible, documentation or identification to confirm their medical condition should be produced. Medication should have a professionally printed

label identifying the medication or a manufacturer's name or pharmaceutical label affixed.

It is forbidden that passengers carry in their baggage articles, liquids, or other substances which are capable of posing a significant risk to health, safety and property when transported by air, including explosives, compressed gases and/or aerosols, flammable liquids, corrosives, oxidising materials, magnets, materials easily ignited, poisonous, offensive or irritating substances, munitions of war and any further items which are prohibited by applicable laws, regulations or order of any state to be flown from, to or over.
